### **PURPOSE OF REQUEST**

The City of Linden is requesting proposals from qualified individuals and firms to provide ("contractor(s)" or "proposer(s)") to provide Redevelopment Counsel Services of a specialized nature to the City. Proposals will be evaluated in accordance with the criteria set forth in this RFQ. One or more individuals/firms may be selected to provide services.

# PERIOD OF CONTRACT

January 1, 2021 through December 31, 2021

# **CONTRACT FORM**

The successful proposer shall be required to execute the City's form contract, which includes the indemnification, insurance, termination and licensing provisions.

It is also agreed and understood that the acceptance of the final payment by Contractor shall be considered a release in full of all claims against the City arising out of, or by reason of, the work done and materials furnished under any Contract awarded.

# DETAILED REQUIREMENTS OF THE REQUEST FOR QUALIFICATIONS FOR REDEVELOPMENT COUNSEL SERVICES

1. <u>CITY OF LINDEN FACTS AND FIGURES</u> – The City of Linden is a municipal governmental entity. The City was incorporated in 1925 and operates under N.J.S.A 40:61A-1 <u>et seq.</u> The legislative authority and responsibilities of the City of Linden is vested in the elected eleven-member Council. The Governing Body sets policy, adopts the operating and capital budgets for the City, enacts

ordinances and sets the direction of how the City of Linden will provide government services. The Mayor is the City's chief executive officer and carries out the policies adopted by the Council.

The City's population is in excess of 40,449 and it consists of approximately 11 square miles of area. The City employs approximately 606 people in about 25 departments and agencies. It owns City Hall, administrative buildings, and parks and recreation facilities. The City's operating budget is over \$110,451,334.69. It provides significant and diverse services to its residents, including those in the senior, disabled, veterans and other communities.

**2.** <u>NATURE/ SCOPE OF SERVICES</u> – The City of Linden is requesting proposals for Redevelopment Counsel Services.

The City of Linden frequently requires outside counsel Redevelopment Counsel for matters relating to redevelopment projects in the City, including approvals, planning, negotiations, litigation and representation of the City, City officials/officers/directors and employees, and including eminent domain actions, acquisition of property, tax abatement negotiations and financing matters.

Redevelopment Litigation Counsel. Counsel will, on an "as needed" basis, be assigned and required to provide representation in all aspects of redevelopment litigation, including but not limited to, preparation of pleadings, motions, and discovery documents; participation in all discovery including attendance at all depositions; participation in and attendance at settlement conferences, pretrial motions and trials.

The City of Linden is requesting proposals for Redevelopment Counsel And Redevelopment Litigation Counsel. Counsel will, on an "as needed" basis, be assigned and required to provide representation as set forth above in consultation with and at the direction of the City Attorney.

Counsel may be called upon to attend meetings.

Counsel may also be called upon to provide other types of legal services of a specialized nature.

- **3.** <u>STANDARD REQUIREMENTS OF TECHNICAL PROPOSAL</u> Proposers should submit a technical proposal which contains the following:
  - **A.** The name of the proposer, the principal place of business and, if different, the place where the services will be provided.
  - **B.** Proposer must have a minimum of ten (10) years of experience in redevelopment work and a minimum of five (5) years servicing the City of Linden or other governmental entities.
  - C. The education, qualifications, experience, and training of all persons who would be assigned to provide services along with their names and titles.
  - **D.** A listing of all other engagements where services of the types being proposed were provided in the past. This should include other City governments and other levels of government. Contact information for the recipients of the similar services must be provided. The City may obtain references from any of the parties listed.

- **E.** A description of all other areas of redevelopment work of the proposer, with emphasis on a description of those services of interest to a City government client.
- **F.** Please provide a description of any particular area(s) of expertise you or your firm may possess that have not been included in the response provided above.
- **G.** A statement that neither the firm nor any individuals assigned to this engagement are disbarred, suspended, or otherwise prohibited from professional practice by any federal, state, or local agency.
- **H.** An Affirmative Action Statement (copy of form attached).
- **I.** A completed Non-Collusion Affidavit (copy of form attached).
- J. A statement that the proposer will comply with the General Terms and Conditions required by the City and enter into the City's standard Professional Services Contract.
- **K.** A copy of the proposer's Business Registration Certificate.
- **4.** <u>SPECIALIZED REQUIREMENTS OF TECHNICAL PROPOSAL</u> Proposer must demonstrate a proven record of cases tried before the Federal District Court for the District of New Jersey and/or demonstrate a proven record of cases tried in the Trial and the Appellate Divisions of the Superior Court of New Jersey;
- **5.** <u>COST PROPOSAL</u> The City of Linden has established the following fee schedule, and shall pay hourly rate:

Redevelopment Counsel-Ongoing projects that are affiliated with the Union County Improvement Authority that will eventually reimburse the City of Linden shall be paid \$350.00 per partner and \$300.00 per associate. Future projects that are not affiliated with the Union County Improvement Authority and directly with the City of Linden shall be paid \$175.00 per hour for such services, depending upon the nature of the case, to be determined by the Law Department.

Redevelopment Litigation Counsel- The City of Linden shall pay an hourly rate of \$125 - \$200. for such services, depending upon the nature of the case, to be determined by the Law Department. This hourly figure may be increased if legal costs are to be recovered from a Redeveloper or any other source.

By submission of a proposal, proposer acknowledges and agrees to adhere to the fee schedule set forth above.

**6. PROPOSAL EVALUATION** – The City will select the most advantageous proposals based on all of the evaluation factors set forth at the end of this RFQ. The City will make the award(s) that is in the best interest of the City.

Each proposal must satisfy the objectives and requirements detailed in this RFQ. The successful proposer shall be determined by an evaluation of the total content of the proposal submitted.

The City reserves the right to:

- **A.** Not select any of the proposals;
- **B.** Select only portions of a particular proposer's proposal for further consideration; (However, proposers may specify portions of the proposal that they consider "bundled".)
- C. Award a contract for the requested services at any time during the calendar year after all RFQ's have been reviewed and a list of qualified Redevelopment Counsel is selected by the City. Every proposal should be valid through this time period.

The City shall not be obligated to explain the results of the evaluation process to any proposer.

- 7. PROPOSAL LIMITATIONS This RFQ is not intended to be an offer, order or contract and should not be regarded as such, nor shall any obligation or liability be imposed on the City by issuance of this RFQ. The City reserves the right at the City's sole discretion to refuse any proposal submitted.
- **8.** <u>USE OF INFORMATION</u> Any specifications, drawings, sketches, models, samples, data, computer programs, documentation, technical or business information and the like ("Information") furnished or disclosed by the City to the proposer in connection with this RFQ shall remain the property of the City. When in tangible form, all copies of such information shall be returned to the City upon request. Unless such information was previously known to the proposer, free of any obligation to keep it confidential, or has been or is subsequently made public by the City or a third party, it shall be held in confidence by the proposer, shall be used only for the purposes of this RFQ, and may not be used for other purposes except upon such terms and conditions as may be mutually agreed upon in writing.

# 9. <u>GENERAL TERMS AND CONDITIONS</u> –

- **A.** The City reserves the right to reject any or all proposals, if necessary, or to waive any informalities in the proposals, and, unless otherwise specified by the proposer, to accept any item, items or services in the proposals should it be deemed in the best interest of the City to do so.
- **B.** In case of failure by the successful proposer, the City of Linden may procure the articles or services from other sources, deduct the cost of the replacement from money due to the proposer under the contract and hold the proposer responsible for any excess cost occasioned thereby.
- C. The proposer shall maintain sufficient insurance to protect against all claims under Workmen's Compensation, General, Professional and Automobile Liability.
- **D.** Each proposal must be signed by the person authorized to do so.
- **E.** The contract shall be in effect through December 31, 2021 unless otherwise stated.
- **F.** Proposals may be hand delivered or mailed consistent with the provisions of the legal notice to proposers. In the case of mailed proposals, the City assumes no responsibility

- for proposals received after the designated date and time and will return late proposals unopened. Proposals will not be accepted by facsimile or e-mail.
- G.
